On 17 February 2019, the Company and VC Brokerage Limited (the “Placing Agent”) entered into a placing agreement pursuant to which Company has conditionally agreed to issue and the Placing Agent has conditionally agreed to place the Convertible Bonds in the aggregate principal amount of up to HK\$64,000,000 at the initial Conversion Price of HK\$1.6 per Conversion Share under the general mandate granted to the board of Directors at the annual general meeting of the Company held on 27 August 2018.
