NETWORK ACCESS LICENCE FOR TELECOMMUNICATIONS
EQUIPMENT FROM THE MINISTRY OF INDUSTRY AND
INFORMATION TECHNOLOGY OF THE PRC

This announcement is made by IBO Technology Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis to keep the shareholders and the potential investors of the Company informed of the latest business development of the Group.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that, as disclosed by the Ministry of Industry and Information Technology of the People’s Republic of China (the “**MIIT**”) on 26 January 2021, Shenzhen IBO Communication Company Limited* (深圳市艾伯通信有限公司) (“**IBO Communication**”), a subsidiary of the Company, has obtained the Network Access Licence for Telecommunications Equipment (the “**Network Access Licence**”) issued by the MIIT, which covers the 5G frequency band of the three major operators, namely China Mobile, China Telecom and China Unicom.

INFORMATION ON NETWORK ACCESS LICENCE

The PRC implements a network access licensing system for telecommunications terminal equipment, radio communications equipment and telecommunications equipment that are connected to public telecommunications networks. The telecommunications equipment subject to the network access licensing system must obtain a network access licence issued by the MIIT. Without the network access licence, it may not be connected to public telecommunications networks for use or sold in the PRC.
