As disclosed in the Announcements and the Circular, pursuant to the Subscription Agreement (as supplemented and/or amended by the Supplemental Agreement, the Second Supplemental Agreement and the Third Supplemental Agreement), subject to the fulfillment or satisfaction of the conditions precedent to the Second Stage Subscription (or having been waived, if applicable), the Second Completion shall take place on 30 September 2021 (or such later date as may be agreed between the parties to the Subscription Agreement in writing). As additional time is required by the Subscriber to complete the financial arrangement in relation to the Second Stage Subscription, on 29 September 2021 (after trading hours), the Company and the Subscriber entered into a fourth supplemental subscription agreement (the “**Fourth Supplemental Agreement**”), pursuant to which the parties mutually agreed to extend the Second Completion to 31 December 2021.

Save and except for the above, all other terms and conditions of the Subscription Agreement (as supplemented and/or amended by the Supplemental Agreement, the Second Supplemental Agreement and the Third Supplemental Agreement) remain unchanged and in full force and effect in all respects.
